







## Fostering gender equality and climate action through sustainable urban mobility

Sustainable mobility supported by public transport as the backbone is vital to ensuring the achievement of the global agendas and that all people and the planet are protected. Mobility and other key local public services play an important role in our daily lives and are essential to fostering social inclusion, access to opportunity, climate action and resilience.

Mobility is directly interlinked with gender equality and women's empowerment through universal access to opportunities and services and through the important effect it can have on health and quality of life, and access to education, among others. Moreover, mobility can contribute to gender equality and social inclusion via the planning of public spaces around key mobility-related services with a significant impact to building greater resilience during periods of distress, and addressing structural inequalities, for example, affecting the rights of persons with disabilities, women and girls.

On the occasion of the 66th Commission on the Status of Women, on the theme of 'Achieving gender equality and the empowerment of all women and girls in the context of climate change, environmental and disaster risk reduction policies and programmes', UCLG is mobilising the constituency gathered in the Global Taskforce of Local and Regional Governments, to host the Local and Regional Government Day on 'Feminist municipalism: empowering women local leaders as a pathway for the achievement of the SDGs'.

This session, entitled 'Fostering gender equality and climate action through sustainable urban mobility' co-organized with UITP and held within the context of the NGO CSW Forum will form one of four different sessions and will bring together local and regional government elected and appointed officials, partners and civil society representatives, to further reflect on the role of local and regional governments and sustainable urban mobility in achieving SDG5, taking stock of the where we stand in 2022, and how we can collaboratively work towards this common agenda towards 2030 and beyond.
